## **TUITION CONTRACT for the 2022-2023 SCHOOL YEAR**

*Please complete one form per child. Retain a copy of each for your records and return the original.*

I agree to enroll my child \_\_\_\_\_, for the 2022-2023 academic year. For families having more than one child enrolled at CMS, there is a 10% reduction in the tuition of a second (or subsequent) child. The reduction must be taken from the lower tuition.

**I enclose a registration fee of \$150 per child, which is *non-refundable and secures my child's spot* for the following year. CMS will fill our classrooms and turn away future applicants based upon your signed tuition contract for your child. Once a contract is signed, a commitment has been made for the *total tuition* for the 2022-2023 school year. It is further understood that this agreement is a legally binding contract for the entire annual tuition.**

I understand that there shall be a six-week trial period beginning on the first day of school or date of admission, whichever is later. If, following the trial period, it is in the opinion of the teachers that the child appears unready for our program, or if by mutual agreement between the teachers and student's parents that the student is unready, tuition will be refunded on a pro-rated basis.

FOR ADDITIONAL SPECIFICS ON OUR REFUND POLICY, TUITION AGREEMENTS, TUITION PAYMENTS, AND LATE FEES, PLEASE REFER TO THE ATTACHED BY-LAWS, ARTICLE 8 A-D.

All payments are due on the first of the month. Any payment received after the **10<sup>th</sup>** of the month will be assessed a \$25.00 late fee per month. In the event any installment payment of tuition is delinquent for more than 30 days, the school has the option to declare the entire tuition balance due and payable immediately. In the event that it becomes necessary to refer this account for collection, it is understood that I will be responsible for all collection fees, including attorney fees, interest, etc.
